## ABRecycling.com Access Request Form

Each user requiring access to *ABRecycling.com* must complete this form. Access is restricted to X \_\_\_\_\_ (“*Supplier Company*”) personnel. *Supplier Company* agrees to notify the Anheuser-Busch Recycling Administrator when those with access no longer are associated with *Supplier Company*, so that their access can be removed.

On completion and acceptance of this form, an ABRecycling.com User ID, password, and access instructions will be returned to the user at the company address specified below. The User ID and password must not be shared or used by others.

User Equipment and Remote Connect Charges. User shall be responsible for obtaining and maintaining, at its own expense, all computer hardware, software, communication equipment and access lines necessary to access and utilize ABRecycling.com.
